
ACRU is protecting votes of active duty military - from Speaker Pelosi

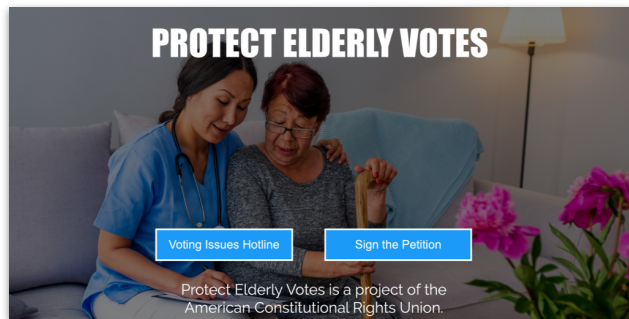

The face of ballot harvesting fraud

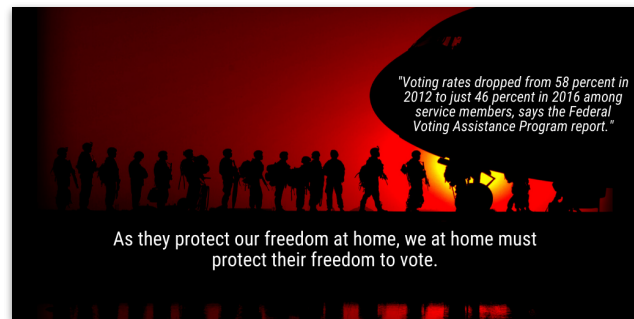
