Military absentee ballots should be requested NOW

The US Military recommends that to be sure your ballot arrives on time, absentee ballot requests should be made by our military by August 1. But you still have time! States are required to mail ballots to you no later than 45 days before an election, but cannot do so without a request. Mail-only voting: unreliable with a high chance of losing your vote

Have you been tirelessly trying to explain that mailonly voting is not absentee voting, not safe, and does not guarantee your vote will be counted? To that end, instead of providing you with one story on the subject, we are giving you a PARTIAL list of mailed vote failures from recent primaries. We hope you will use this list as a resource for debates with folks who either don't understand the problem, or claim it does not exist:

California - 100,000+ mailed ballots not counted

Nevada - 223K mailed ballots not counted New York - 80,000 mailed ballots not counted

Ohio - 300 mailed ballots not counted in one county

Florida - 18K+ mailed ballots not counted
