### Garden State election forecast: cold, with a high chance of fraud

#### North Carolina Governor invents photo ID crisis then tries to "fix" it

7.5 million North Carolina residents have drivers licenses. Half that number - 4.6 million North Carolinians - voted in 2016. The charge for a non-driver photo ID is \$14 and is free to the homeless or disabled. Yet the liberal governor claims photo ID is disenfranchising. Perhaps it's the state's law requiring non-citizens to present legal residency proof (green card, etc.) for photo ID that is giving him angst, as two weeks ago 19 non-citizens in the state were charged with felony vote fraud.
