
We hope you will take a moment to watch this important video and circulate to any seniors, their family members and senior residence staff. You can help us protect senior votes!

## ACRU's Toloczko: the military can still vote with Federal Write-In Ballots



#### OHIO

#### Capital-area county sends out broken ballots

In the county that contains Ohio's seat of government, 21% of absentee ballots sent to voters were incorrect. Some had the wrong congressional race and some had the wrong voting precincts. Vote fraud is real, and so is election office incompetence. Both result in false results. Like similar cases in Michigan and New York, officials are sending new ballots to further confuse people. ### NEW JERSEY

#### Liberal governor's unsolicited ballot fiat creates havoc for voters

New Jersey Democrat Governor Phil Murphy used COVID as an excuse to mail ballots to every address in the state, whether the addressee is alive or dead, or relocated. NJ election officials, overwhelmed by this unnecessary political maneuver, can't get it right. In Bergen County, officials sent out nearly 7,000 incorrect ballots to 28,000 voters.
