
ACRU's Roman: Message on the election

ACRU has been working to prevent vote fraud for nearly a decade. In 2020, operatives on the left have taken actions in courts and state legislatures to eradicate voting integrity laws across the U.S. Using Covid as an excuse, they have convinced lawmakers and judges to undo protections passed by elected representatives to deter fraud. ACRU has been working and warning against this all year. The left spent millions of dollars in efforts to:

- Eliminate voter ID
- Eradicate signature comparisons
- Extend deadlines for ballots to be returned after election day
- Get rid of requirements to be postmarked by election day
- Void state laws banning vote harvesting by third parties
- Enact widespread mailing of ballots to every person on voter rolls, with full knowledge that voter rolls are filled with deceased and relocated voters.

Each of these measures is intended to make it easier to commit vote fraud and harder to detect and prove once done. This is why we have an election like no other. Our system has been

Anecdotal evidence from a Texas Nursing home

American Constitutional Rights Union (ACRU) has provided affidavits to the Texas Attorney General as part of a request for a criminal investigation into alleged vote fraud committed against a resident with dementia in a Texas nursing home.

In April of this year, ACRU launched its Protect Elderly Votes project to protect seniors from vote fraud and ballot manipulation by providing resources and guidance to seniors, senior residence staff, and anyone assisting the elderly with voting.

A vote fraud hotline has also been advertised throughout the country for residents and their family members to utilize to report suspected fraud. 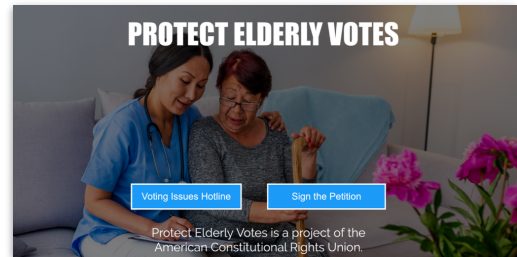

Organized ballot harvesting in senior residences being investigated

In a state where ballot harvesting is illegal, a remarkable coincidence occurred right before election day. According to reports from the Senate Judiciary Committee, 25,000 nursing home residents in different facilities across the state all requested ballots at the same time. Who ordered them? TEXAS

Social worker faces ten years in jail for stealing senior votes

A Lone Star social worker has been charged with 137 felony counts of vote fraud related to nursing home residents' votes. Ms. Brunner submitted ballot applications for residents at the nursing home where she worked, many of whom were not legal Texas voters; some had been deemed mentally incapacitated by a court. Military vote counting extends past election day

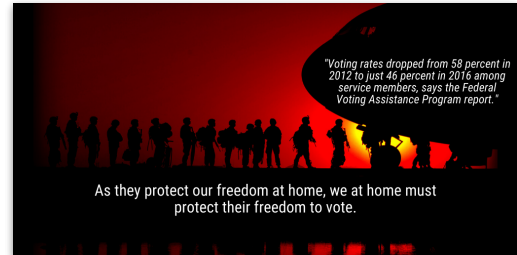
Many states allow processing military votes after election day. In many battleground states, these votes could make a difference in final counts. One of our leadership staff reports that her son, stationed at an EU Army base, never received his ballot from Virginia despite requesting it well within guidelines. Suppression or incompetence? In 2018, one in six military voters did not vote because their requested absentee ballot arrived late or not at all. Protection of military votes will continue to be an ACRU priority in every election. See story [here](#).

Anecdotal military ballot fraud evidence from Detroit

Another story from our hotline was from “John,” a vote count observer at Detroit’s Cobo Hall who told us: “I am mind numbed by the blatant falsification of ballots, particularly military ballots. Unverifiable ballots showed up with no explanation of where they came from. There were 4 Democrat observers and only 1 Republican—who were constantly bullied; at least those they allowed in.” ACRU directed John to legal authorities and he is now preparing to be part of a vote fraud lawsuit in Michigan.

MICHIGAN

Stealing votes from the deceased

It takes coordination for 10,000 dead people to submit ballots from the grave. A Michigan pollster used the Social Security index to find 9,500 confirmed deceased Michiganders who “voted” in this election, and another 2,000 over 100 years old and not listed in databases as living. Hear no ballots, see no ballots, speak no ballots

As the liberal press throws “unsubstantiated!” or “baseless!” at nearly every reported case of vote fraud, in Pennsylvania, an election attorney has presented evidence that as many as 638,000 ballots were counted with Republican election observers blocked from witnessing the count. The narrow electoral results in Wisconsin (a Biden lead of only about 20,500 votes) have triggered a canvassing process to certify results. After the canvass is complete (likely by next Tuesday) the Trump campaign can request a recount.
